Incorporated as a Florida nonprofit organization in August 2022 to fill a void left by the closure of a predecessor, BIF is determined to promote effective awareness, education, outreach, treatment, prevention, advocacy and support for survivors of acquired brain injury, and those interested and involved in their care, recovery, and quality of life. To keep this commitment, we have:

- opened the Brain Injury Information Line to respond to the needs of our constituents,
- created committees of interested stakeholders to assess the needs of, and opportunities to become, one of the most effective statewide advocacy groups in the country,
- become the state affiliate of the Brain Injury Association of America to ensure that there is communication with, and advocacy for, the needs of

Floridians on a national level, and a transfer of information regarding the best evidence-based treatments and promising treatments,

• partnered with the University of Florida to attract an ACL Grant to enable the creation of the

Sunshine NeuroResource Facilitation Network and update the Florida Strategic Plan for Brain Injury,

- created a Brain Injury Coalition of interested state agencies, NGO's and individuals to further support and efforts for legislative change, and
- held three annual education conferences to create new avenues of communication.
